ORDER

As per GO read as 2nd paper above, Sri. Ramesh. K. P., Executive Engineer, Kozhikode Development Authority was absorbed in the LSGD Engineering Wing and he was assigned seniority as junior most in the cadre of Executive Engineer in the department as on 01.04.2017.

2. The seniority list of Executive Engineers including those who were promoted upto 07.12.2016, was published, vide GO read as 1st paper above. Now pursuant to orders in GO dated 20.03.2020, the Chief Engineer has published the draft seniority list of Exe.Engineers for the period from 31.12.2016 to 31.08.2018 on 08.06.2020, in continuation of the seniority list published vide GO(Ms) dated 19.07.2017, incorporating the name of Sri. Ramesh K. P. as rank no.1 after assigning his seniority as junior most in the cadre of Exe.Engineer as on 01.04.2017.

3. The Chief Engineer, vide letter read as 3rd paper above, has forwarded the draft seniority list published along with details of objections and report thereon for finalisation of the same. The contentions in the objections received and the facts thereon are summarised as follows;

i. **Smt. Rany G.** – The incumbent was promoted as Executive Engineer as per GO (Rt) no.1607/2019/LSGD dtd 27.07.2019 pursuant to her inclusion in the modified select list 2018 for promotion to the post of Exe.Engineers as '6a' just below Sri. Rajesh D. and above Sri. Harikumar M. G. Therefore, it is requested to include her name in the seniority list in between the said officials as there in the select list. Her name has been included as Rank no.34 in between Sri. Rajesh D. and above Sri. Harikumar M. G. in the seniority list and thus the objection has been finalised.

ii. **Smt. Fathima V. M., Sri. Sandeep K. G., Smt. Seena Alex E., Sri. K. C. Subramanian, Sri. Ajithkumar G. and Smt. Ganga R. S.** have raised objections against the inclusion of Sri. Ramesh K. P. as Rank no.1 in the draft seniority list with assigning his seniority as junior most in the cadre of Exe.Engineer w.e.f 01.04.2017.

Sri. Ramesh K. P., Exe.Engineer among other Engineering Staff of the defunct

Kozhikode Development Authority was absorbed into the LSGD Engineering Wing as per the policy decision of Govt ordered vide GO (Ms) NO. 73/2017/LSGD dtd 30.03.2017 and thereafter reassigning his seniority as junior most in the cadre of Exe.Engineer in the department as on his date of joining in the department vide GO (Ms) no. 54/2020/LSGD dtd 20.03.2020, issued as per the decisions of the Council of Ministers. Based on these facts the objection deserves no merit and hence the same is hereby declined.

iii. **Sri. Manikandakumar T.** has raised objections against inclusion of his juniors in the cadre of Asst.Engineer above that of him in this draft seniority list of Exe.Engineers. The anomaly can only be rectified while reviewing the select list for promotion to the post of Exe.Engineers made after the review of the select list for promotion to Assistant Executive Engineer cadre in compliance with the Hon'ble Supreme Court direction.

iv. **Sri. Sandeep K. G.** has also raised objections against the inclusion of Sri. Johnson K. in the seniority list. The said objection is not at all maintainable as Sri. Johnson K. was found eligible for promotion to the cadre of Exe.Engineer in accordance with the extant special rules by the DPC(H) 2017 held on 24.10.2017, being the competent authority to do so. Based on this, the incumbent found place in the seniority list in the exact position. Therefore, the argument is not maintainable according to the clear cut provisions in the Special Rule and the objection is hereby declined.

v. **Smt. Seena Alex E.** has also requested to correct her date of birth and the qualification mentioned in the draft seniority list. The corrections as requested by the incumbent have been made in the seniority list.

All the objections raised against the draft seniority list of Executive Engineers have been disposed of as above. Hence the Government are pleased to approve the finalised seniority list of Executive Engineers of LSGD Engineering Wing for the period from 31.12.2016 to 31.08.2018 annexed to this order and to publish the same.
