TRAINING CIRCULAR

Subject:- Online Knowledge Co-Creation Program on "Housing Supply Policy" from 30th November to 9th December, 2021.

The Government of Japan has invited nominations for online training course on "Housing Supply Policy" from 30th November to 9th December, 2021 under the Technical Cooperation Programme with India. The course is intended for governmental officials responsible for improvement of housing and living environment. The eligibility conditions and other information about the course are mentioned in the Information Booklet received from the sponsoring Government (Annex-I). Number of slots available for India is one regular candidate and one reserved candidate.

2. Nomination of candidates is regulated by the guidelines prescribed by DEA, a synopsis of which is attached as **Annex-II**.

3. **The course is sponsored by** the Government of Japan, and there is no need to the cost of round-trip airfare and other related expenses.

4. The following forms need to be duly completed and certified by the participant and the competent authority of the nominating Ministry/Department:-

- (iv) Sponsoring Government's application form.
- (v) DEA's prescribed proforma - duly countersigned by competent authority (**Annex-III**).
- (vi) A photocopy of the Passport.
