Govt. have accorded sanction to conduct 2 Years M.Tech Programme in translational Engineering at Government Engineering College, Barton Hill, Thiruvananthapuram. Vide ref (3), it is informed that the admissions for the 8th batch of M.Tech Translational Engineering Course is in progress. Admission to the M.Tech Programme in Translational Engineering is made on the basis of total marks obtained for the qualifying examination and a personal Interview. The registration to this course starts from 19th July 2022 and ends at 18th August 2022. The Engineers who are willing for deputation may submit their Bio-data, Copies of Degree Certificate and mark lists through proper channel in the Performa enclosed with undertaking on or before 05/08/2022. The next higher authority of the applicant should counter sign in each page of request including the copies of Degree Certificates and Mark List.

This Department shall select candidates as per norms and nominate them. The selected candidates shall apply as per instructions shown in the prospectus. Besides Engineers are require to follow certain conditions for the selection to the course stipulated in the prospectus issued by the College of Engineering, TVM. The Scheme

for deputation of Engineers to M.Tech Translational Engineering Course subject to conditions are furnished below.

Scheme for deputation to M.Tech Translational Engineering Course

1. Eligible and willing Officer shall possess a minimum 2 Years of regular service in the department and should have declared their probation and should not be aged over 40 year as on the date of application for the Course.
2. Candidates must have a minimum of 60% marks in the qualifying examination. Suitable & willing officers shall submit their application with bio data , marklist, & degree certificate in duplicate.
3. Sponsored Candidate, if they fail to qualify within the period specified in KTU ordinance / regulation the entire expense incurred by Govt. for them should be refunded to the concerned Department. Within 6 months after qualification they have to present of a project before their department Head as to how the knowledge they have acquired can be applied in this department in an Engineering Project. Before admission to this Course they shall execute a bond on non-judicial stamp paper worth Rs 200/- to the effect that they shall serve the Government for minimum period of 10 years on successful completion of the course.
4. For Sponsored Candidates who wish to take admission in M.Tech Translational Engineering must submit a two page proposal of an issue about solid waste management in rural & urban areas in kerala for which they will carry out the research and bring up the solution at the end of course.
5. In case the period of deputation is extended due to non completion of course. Within the stipulated time they will have to execute revised agreement in conformity with the total period of deputation as revised and refixed as per condition No. (IX) of G.O (P) No. 303/70/Fin dated 12.05.1970. The cost of extended period (both tuition fee and all other charges) shall not be borne by department / Government.

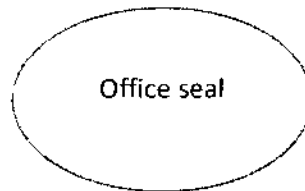

WHEREAS the Bounden Shri/Smthas been
selected to undergo. (here
enter the name of the course of study) in Government Engineering College,
..... (Name of College), Kerala for a period of two/three years.

AND WHEREAS the Government have agreed to pay the Bounden during the
period of the said course of study his/her pay and allowance which he/she would have drawn
but for his undergoing the said course of study and to treat the period of the course of study as
duty

ANDWHERE AS the Government have agreed to incur the said expenses on condition
that after successful completion of the course of study within the prescribed period the bounden
shall serve the Government for a period of 10 years out of which 2 years should be in Difficult
and remote area as defined by the state Government to be served immediately after the
completion of the course and also subject to the terms and conditions here in after appearing
and the bounden and the sureties have agreed to the same.

NOW the condition of the above written obligation is that in the event the
Bounden discontinues the course on any reason/ do not opt for the speciality within a period
of one month after completing the course/ resign from the service or take voluntary retirement/
leave the service to take up another appointment elsewhere or for any other reason
before completing mandatory period of service of 10 years after successful completion of the
course of study, the Bounden and sureties shall forthwith pay to the Government on
demand the sum of Rs an amount equal to the total salary admissible to the officer

during the entire period of obligatory service of 10 years as the case may be after completing the course. The salary drawn during the course along with interest @ 8% will also be recovered towards liquidated damages. In order to arrive at the future salary, a hike of 25% on the existing salary will be effected in quinquennial pay revision taking place the obligatory period. In the matter of deciding what moneys are to be paid by the Bounden and the sureties the decision of the Government shall be final and legally binding on the bounden and sureties and upon the payment of such sum the above written obligation shall be void and of no effect otherwise this shall be remaining full force and effect.

PROVIDED further that the bounden and the sureties do hereby agree that if the Bounden fails to serve the Government for a period of 10 years, it may be construed as professional misconduct and the fact reported to the Administrative Department for necessary action and his/her service will be terminated by following procedure under the Kerala Civil Services (Classification Control and Appeal) Rules, 1960.

PROVIDED further that the bounden and the sureties do hereby agree that all sums found due to the Government under or by virtue of this bond may be recovered jointly and severely from them and their properties movable and immovable as if such dues were arrears of land revenue under the provisions of the Revenue Recovery Act for the time being force or in such other manner as the Government may deem fit.

THE liabilities of the sureties under this Bond is Co-existent with that of the Bounden and shall not be affected by the Government giving time or any other indigence to the bounden or by the Government varying of the terms and conditions here in contained.

It is agreed that the certificates submitted at the time of admission will be released by the Principal only after satisfactorily completing the bonded obligation.
