NOTIFICATION

G. O. (P) No. 133/2009/LSGD. Dated, Thiruvananthapuram, 16th July, 2009.

S. R. O. No. 620/2009.—In exercise of the powers conferred by sub section (1) of section 2 of the Kerala Public Service Act, 1968 (19 of 1968) the Government of Kerala hereby make the following amendments to the Special Rules for the Kerala Local Self Government Engineering Service, 2007 issued under Notification: G. O. (P) No. 271/2007/LSGD, dated 27th November, 2007 and published as S. R. O. No. 995/2007 in the Kerala Gazette Extraordinary No. 2149 dated 27th November, 2007, namely:—

RULES

1. *Short title and commencement.*—(1) These Rules may be called the Kerala Local Self Government Engineering Service (Amendment) Special Rules, 2009.

(2) They shall be deemed to have come into force with effect from 1st January, 2008.

2. *Amendment of the Rules.*—In the Special Rules for the Kerala Local Self Government Engineering Service, 2007,—

In sub-rule (1) of rule 3, after category 4, the following note shall be added namely:—

“Note: Promotion to the category of Assistant Executive Engineer shall be made from among direct recruits and diploma holders in the feeder category in the ratio of 3:1”.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G. O. (Ms.) No. 253/2007/LSGD dated 13th November, 2007 Local Self Government Engineering Cadre was created drawing staff from various sources mentioned therein. The Special Rules for the Local Self Government Engineering service consisting of the Chief Engineer, Superintending Engineer, Executive Engineer, Assistant Executive Engineer and Assistant Engineer were notified as per S.R.O. No. 995/07 dated 27th November, 2007 prescribing the methods of appointment, qualification etc. for those posts. But in the Special Rules a ratio for the promotion to the category of Assistant Executive Engineer from among Direct Recruits and Diploma Holders in the feeder category was not specified. Due to this omission the Seniority List of Assistant Engineers could not be prepared and promotion to the post of Assistant Executive Engineer could not be effected. In the Special Rules for Kerala Engineering Service, 1965, it was specified that vacancies in the category of Assistant Executive Engineers shall be filled up from among Assistant Engineers between Degree Holders and Diploma Holders in the ratio 3:1. Since majority of the Assistant Engineers in the newly created Engineering cadre of Local Self Government Department are deployed from Public Works Department and Water Resources Department, it is decided to incorporate the above ratio in the Special Rules for the Kerala Local Self Government Engineering Service, 2007.

This notification is intended to achieve the above purpose.
