Vikram Sarabhai Space Centre, ISRO, Thiruvananthapuram under the Department of Space, fully depends on M/s BSNL for all its telecom services and internet connection. All the communication links are maintained by BSNL through Optic Fiber Connectivity and the links are critical during Launch campaigns. Recently, a serious interruption in the communication link of VSSC has occurred due to the damaging of OFCs of BSNL as part of excavation works performed by private agency.

In the circumstance, you are directed to intimate BSNL authorities before the excavation works/digging works, so as to avoid similar fiber breaks in BSNL links in future.
